SPECIFICATION & SPECIAL CONDITIONS OF CONTRACT:

- 1. Unless otherwise specified the work shall be carried out in accordance with the printed CPWD specification for the works at Delhi correction slips issued till the date of opening of tenders/quotation. In the event of any dispute the followings shall be the order of priority to decide the issue:
 - a. Nomenclature of item read with special conditions of the contract and general specifications
 - b. CPWD specifications
 - c. ISI specifications
 - d. Instructions of NIPER-A officials.
- 2. Before quoting the contractor shall inspect the site of work, take necessary measurements at their own, and shall fully acquaint him-self about the conditions with regard to accessibility of site required for the satisfactory execution of work. No claim whatsoever shall be entertained by the Institute on this account.
- 3. The actual measurements should be taken by the bidder before proceeding for the fabrication work since the removal of wooden flooring may modify the measurements.
- 4. The quantities shown in the schedule are indicative / tentative and may change as per site conditions. The Contractor shall not claim anything extra on this account. The payment shall be made as per actual quantities of work done on site and as per the conditions of the contract.
- 5. The work executed under the contract shall be subject to inspection carried out by the Institutes' officials. Any defects regarding workmanship or quality of material to be used as pointed out during or after completion of work by the Institutes' officials shall have to be rectified by the contractor and in case the contractor fails to do so, it will be got rectified by the Institute at the risk and cost of the Contractor.
- 6. All precautionary measures should be adopted for the safety purposes for any accident during the execution of work occurring at site, the contractor shall be overall responsible for the same.
- 7. Quantity of the work shall be measured as per IS:1200 mode of measurements and shall be paid accordingly.
- 8. The work shall be executed without any loss / damage to the client's existing property. In case any damage occurred to the existing structure the same should be rectified by the Contractor on their own cost.
- 9. The Contractor shall clean the site after completion of work in all. Any

dismantled material shall be stacked in designated place as instructed by the NIPER-A individual.

- 10. GST registration of contractor is mandatory. Quoted price shall be inclusive of GST and cartage etc.
- 11. Any claim on account of price escalation and revision in taxes shall not be payable.
- 12. Taxes shall be deducted from the bill as per GOI rules for which the Contractor will submit a PAN, in the name of registered company or proprietor for Depositing TDS.
- 13. No advance payment will be made.
- 14. Security Deposit shall be deducted @ 5 % from the bill of the Contractor and shall be released after expiry of defect liability period of 6 Months after date of completion.
- 15. The work and items shall be guaranteed for defect liability period of 6 months from the date of its final completion.
- 16. The deviation limit for the work can be maximum of \pm 10%, with prior justification by the service provider and approval of NIPER-A officials.
- 17. Electricity and water required for executing the work shall be provided by the institute.
- 18. All materials brought at site shall be approved by the NIPER-A individual before being used.
- 19. The contractor should sign & stamp all pages of the quotation including the pages of the notice which shall mean that the contractor is in acceptance to all the terms and conditions mentioned in the notice.
- 20. Validity of quote is to be for 1 month from the date of quotation.
- 21. 100% payment to be made after successful installation, integration and commissioning of the work and handing over the site.
- 22. 0.5% penalty per week will be charged if the work is not completed in the stipulated time.
- 23. Partially filled BOQ is liable to be rejected.
