In a Rate Contract, neither quantity is mentioned nor any minimum drawl guarantee is given. In other words, the Rate Contract is in the nature of a standing offer from the supplier firm. Once a supply order is placed on the supplier for the supply of a definite quantity in terms of the rate contract during the validity period of the rate contract, that supply order becomes a valid and binding contract.

#### **Bid Validity**

- a. All the Bids must be valid for a **period of 180 days** from the last date of submission of the tender for the execution of the Contract. However, the quoted rate should be valid for the initial/ extended period of the Contract from the effective date of the Contract. No request will be considered for price revision during the original Contract period.
- b. A bid valid for a shorter period shall be declared as non-responsive.
- c. In exceptional circumstances, prior to the expiry of the original time limit, NIPER Ahmedabad may request the bidders to extend the period of validity for a specified additional period beyond the original validity of 180 days. The request and the bidders' responses shall be made in writing. The bidders, not agreeing for such extensions will be allowed to withdraw their bids without forfeiture of their Bid Security.

#### Last Date for Submission of Tender

- a. Online bids complete in all respects, must be submitted on or before the last date and time specified in the schedule of events.
- b. The NIPER, Ahmedabad may, at its own discretion; alter/extend the last date for submission of tenders.

#### Modification / Substitution/ Withdrawal/Rejection of bids

- a. No Bid shall be allowed to be modified, substituted, or withdrawn by the bidder after the bid submission end date.
- b. Any alteration / modification in the Bid or additional information supplied subsequent to the Bid's due Date, unless the same has been expressly sought for by the Authority, shall be disregarded.
- c. The bid submitted shall become invalid if:
  - 1) The bidder is found ineligible.
  - 2) The bidder does not upload all the documents as stipulated in the bid document.

#### **Financial Bids**

The financial bid should be inclusive of all applicable taxes, duties, fees, levies, transport charges, freight, loading-unloading, packing-unpacking, custom duties, insurance, or any other similar charges imposed under the applicable laws.

The rate of GST should be mentioned clearly. GST is to be levied over and above the rate quoted by you, the rate at which GST is to be levied must be specified.

#### **GENERAL TERMS & CONDITIONS OF THE CONTRACT**

The Terms and Conditions as mentioned below would be binding to all parties

#### 1. Parties

The parties to the contract are the supplier (the bidder to whom the work will be awarded) and the National Institute of Pharmaceutical Education and Research (NIPER) Ahmedabad.

#### 2. Earnest Money Deposit (EMD) / Bid Security

The bidder shall be required to submit EMD of an amount of Rs. 25,000/- (Rupees Twenty Five thousand Only) in the form of Demand Draft / Banker's Cheque issued from any of the Scheduled Commercial Banks in favour of "NIPER Ahmedabad". The bid submitted without EMD / Security Deposit will be summarily rejected.

#### 3. Performance Security

- a) The successful bidder will be required to furnish a Performance Security Deposit of an amount of Rs. 50,000/- (Rupees Fifty thousand Only) within 14 days after receiving of letter of Rate contract in the form of Insurance Surety Bonds, Account Payee Demand Draft, Fixed deposit Receipt, Banker's Cheque or Bank Guarantee / e-Bank Guarantee from any of the commercial banks duly pledged in the name of the "Director, NIPER Ahmedabad" which shall be kept valid for a period of 60 days beyond completion of all the contractual obligations.
- b) In case of renewal of the contract the supplier has to submit a revised security deposit for the extended period.
- c) The security deposit can be forfeited by order of this Institute in the event of any breach or negligence or non-observance of any condition of the contract or for unsatisfactory performance or non-observance of any condition of the contract. Performance Security will be discharged after completion of the contractor's performance obligations under the contract.
- d) No interest on the performance security deposit shall be paid by the NIPER Ahmedabad to the Bidder.
- 4. Any conditional or unresponsive bid shall be rejected summarily and will treated as null and void.
- 5. No bid shall be accepted without the EMD. However, relaxations provisioned in GFR 2017 and its amendment thereof, shall be applicable. The bidders claiming an exemption for experience and annual turnover must upload valid certificates for the items being tendered issued by MSE/NSIC/SSI etc. in accordance with prevalent rules and regulations.

#### 6. Scope

- a) Gas and LN2 must be delivered/filled at least every week or 24 hours prior to the notice.
- b) NIPER-A requires the delivery of Gases and LN2 in a staggered manner. Quantity should be supplied as and when required basis. Supply should be made only after getting intimation from the NIPER-A user department.
- c) The bidder is responsible for collecting empty cylinders from NIPER-A. No additional separate charges shall be paid for collecting empty cylinders and delivering filled-up cylinders to NIPER-A as and when demanded. There should not be any rent on the cylinders kept at NIPER-A.

#### 7. Payment

Payment by bank transfer will be made within 30 days after the successful delivery of materials and found in order of purity, quality, and quantity.

#### 8. Inspection and Acceptance Tests

The inspection shall be carried out by the supplier in respect of the purity of Liquid Nitrogen at his premises and the inspection report shall accompany the supply. The NIPER-A shall have the right to verify the inspection done by the supplier at his premises. The supplier shall provide all the facilities required for such verification of inspection to the inspector of the NIPER-A, free of cost. In case verification of inspection is carried out by the NIPER-A at the premises of the supplier prior to the dispatch of Gases and Liquid Nitrogen, an inspection certificate duly signed by the Inspector of the NIPER-A shall be given to the supplier. NIPER-A reserves the right to inspect the products supplied after receipt at its premises.

#### 9. Liquidated damages

Time is the essence of the supply under a rate contract. Supplies made after 48 hours from the receipt of notice from NIPER-A shall be subject to non-performance deduction. A clause is applicable for delayed supplies beyond 48 hours and a deduction shall be calculated on the value of the respective Consignment for which the supplier failed to deliver. NIPER-A will recover an agreed amount not by way of penalty, equivalent to an amount of 0.5% of the value of the consignment per every two hours of delay or part thereof subject to a maximum of 10% of the value of the consignment.

#### 10. Safety Measures

Proper and protective safety measures for handling gases and liquid nitrogen at the NIPER-A site are the responsibility of the supplier. NIPER-A will not be responsible for any accidents that occurred during the transfer of gases and Liquid Nitrogen. All other safety precautions for the transport should be as per PESO rules and safety guidelines of the Government of India. A valid PESO certification document shall be produced to NIPER-A personnel as and when demanded.

- 11. At any time prior to the last date of submission of the bid, Director, NIPER Ahmedabad, for any reason or decision, can modify the terms and conditions of the tender document by a corrigendum displayed on the CPPP as well as the website of NIPER Ahmedabad <a href="http://www.niperahm.ac.in">http://www.niperahm.ac.in</a> In order to provide reasonable time to take the amendment into account in preparing their bid, Director, NIPER Ahmedabad may or may not, at its discretion, extend the date and time for submission of tenders.
- 12. The empanelment and rate contract is initially for the financial year 2023-24 and may be renewed/ extended for another two financial years on mutual consent, subject to satisfactory performance and on the same terms and conditions.
- 13. NIPER Ahmedabad reserves the right to keep the number of firms in the Rate contract for similar items during the period of the Rate Contract with one or two parties. Any parallel rate contract for similar items can be placed at any time during the period of the rate contract with one or more firms/manufacturers by NIPER Ahmedabad.
- 14. The empanelment can be terminated without any notice in case the performance of the party is found consistently unsatisfactory or due to a serious lapse on the part of the bidder. Where lapses are of serious nature in addition to termination of the contract NIPER Ahmedabad will forfeit its performance security.
- 15. The NIPER-A shall not be under any obligation to accept the lowest or any other offer received in response to this tender notice and shall be free to reject any or all offers.
- 16. The acceptance of the bid will rest with the Director, NIPER-A, who does not bind to accept the lowest quotation and reserves the right to herself/himself reject or accept, partially or all the quotations received, without assigning any reason. The Director, NIPER-A further reserves the right to withdraw the tender or part thereof or modify the requirements without assigning any reason and the right to relax any of the conditions in the best interest of the Institution.
- 17. Director, NIPER Ahmedabad shall be the final authority for the settlement of any dispute, and his/her interpretation of any clause/term/condition(s) of this document shall be final and binding, and the jurisdiction of the Court of Law shall be Ahmedabad / Gandhinagar.
