Specifications of Laboratory Rodent Corn Cob (Mice and Rats) (Bedding material)

Dry, clean, good quality with uniform particle size of 5-8mm and without dust particles (double processed). Corncobbedding materials must have excellent absorbing capacity, non-toxic to animals and non- palatable. The corncob should be free from foreign/extraneous material, insects and weevils. Also it should be free from residues of pesticides, free from heavy metals as well. The corncobshould be packaged in double layered high density polyethylene as well as moisture proof bag. The corncob should have minimum shelf life of 6 months from the date of delivery.

The corncob bedding material should be delivered at the door step of the Institute including getting the bedding material to the storage room of the Central Animal Facility without any extra charges.

The corncob will strictly be checked at the time of receiving. If corncob is not found as per the specifications mentioned above, it will be straightway rejected and the vendor will have to replace the corncob immediately. The institute will not bear the transportation cost of the returned material.

Specifications of Laboratory Rodent Pelleted feed (Mice and Rats)

The pelleted feed should have 5-6% fat along with crude protein 18-20% and should meet the dietary requirements of trace elements and essentials vitamins of rats and mice required for their normal physiological and metabolic functions including the needs of pregnant and lactating mothers as well. It should be free from phytoestrogens and other growth retardant feed components. It should be gamma irradiated and must have shelf life of minimum of 6-9 months from the date of delivery. The pellets should be of 10-12mm in size and packaged in double layer thermoplastic Polypropylene bags. The ingredients used for pellet making should be freefrom pesticide residue and heavy metals. Manufacturing facility must be GMP certified. Feed should be processed with Radio frequency irradiation/Gamma irradiation.

The food material should be delivered at the door step of the Institute including getting the food material to the storage room of the Central Animal Facility without any extra charges.

The food will strictly be checked at the time of receiving. If the food is not found as per the specifications mentioned above, it will be straightway rejected and the vendor will have to replace the food immediately. The institute will not bear the transportation cost of the retuned material.

Bid Validity

- a. All the Bids must be valid for a **period of 90 days** from the last date of submission of the tender for the execution of the Contract. However, the quoted rate should be valid for the initial/ extended period of the Contract from the effective date of the Contract. No request will be considered for price revision during the original Contract period.
- b. A bid valid for a shorter period shall be declared as non-responsive.
- c. In exceptional circumstances, prior to the expiry of the original time limit, NIPER Ahmedabad may request the bidders to extend the period of validity for a specified additional period beyond the original validity of 180 days. The request and the bidders' responses shall be made in writing. The bidders, not agreeing for such extensions will be allowed to withdraw their bids without forfeiture of their Bid Security.

Last Date for Submission of Tender

- a. Online bids complete in all respects, must be submitted on or before the last date and time specified in the schedule of events.
- b. The NIPER, Ahmedabad may, at its own discretion; alter/extend the last date for submission of tenders.

Modification / Substitution / Withdrawal / Rejection of bids

- a. No Bid shall be allowed to be modified, substituted, or withdrawn by the bidder after the bid submission end date.
- b. Any alteration / modification in the Bid or additional information supplied subsequent to the Bid's due Date, unless the same has been expressly sought for by the Authority, shall be disregarded.
- c. The bid submitted shall become invalid if:
 - 1) The bidder is found ineligible.
 - 2) The bidder does not upload all the documents as stipulated in the bid document.

Financial Bids

The financial bid should be inclusive of all applicable taxes, duties, fees, levies, transport charges, freight, loading-unloading, packing-unpacking, custom duties, insurance, or any other similar charges imposed under the applicable laws.

The rate of GST should be mentioned clearly. GST is to be levied over and above the rate quoted by you, the rate at which GST is to be levied must be specified.

GENERAL TERMS & CONDITIONS OF THE CONTRACT

The Terms and Conditions as mentioned below would be binding to all parties

1. Parties

The parties to the contract are the supplier (the bidder to whom the work will be awarded) and the National Institute of Pharmaceutical Education and Research (NIPER) Ahmedabad.

2. Earnest Money Deposit (EMD) / Bid Security

The bidder shall be required to submit EMD of an amount of Rs. 30,000/- (Rupees Thirty thousand Only) in the form of Demand Draft / Banker's Cheque issued from any of the Scheduled Commercial Banks in favour of "NIPER Ahmedabad". The bid submitted without EMD / Security Deposit will be summarily rejected.

3. **Performance Security**

- a) The successful bidder will be required to furnish a Performance Security Deposit of an amount of Rs. 30,000/- (Rupees Thirty thousand Only) within 14 days after receiving of letter of Rate contract in the form of Insurance Surety Bonds, Account Payee Demand Draft, Fixed deposit Receipt, Banker's Cheque or Bank Guarantee / e-Bank Guarantee from any of the commercial banks duly pledged in the name of the "Director, NIPER Ahmedabad" which shall be kept valid for a period of 60 days beyond completion of all the contractual obligations.
- b) In case of renewal of the contract the supplier has to submit a revised security deposit for the extended period.
- c) The security deposit can be forfeited by order of this Institute in the event of any breach or negligence or non-observance of any condition of the contract or for unsatisfactory performance or non-observance of any condition of the contract. Performance Security will be discharged after completion of the contractor's performance obligations under the contract.
- d) No interest on the performance security deposit shall be paid by the NIPER Ahmedabad to the Bidder.
- 4. Any conditional or unresponsive bid shall be rejected summarily and will treated as null and void.
- 5. No bid shall be accepted without the EMD. However, relaxations provisioned in GFR 2017 and its amendment thereof, shall be applicable. The bidders claiming an exemption for experience and annual turnover must upload valid certificates issued by MSE/NSIC/SSI etc. in accordance with prevalent rules and regulations.

6. Payment

Payment by bank transfer will be made within 30 days after the successful delivery of materials and found in order of purity, quality, and quantity.

7. Inspection

- a. NIPER Ahmedabad shall have the right to inspect and/or to test the goods to confirm their conformity to the Tender Specifications at no extra cost to the NIPER Ahmedabad
- b. The rate contract of the firm may be subject to verification of the firm's credentials or physical inspection of production units/sales office
- c. The Director, NIPER Ahmedabad shall be the final authority to reject full or any part of the supply which is not conforming to the specification and other terms and conditions.
- d. No payment shall be made for rejected Stores. Rejected items must be removed by the Bidders within one week from the date of rejection at their own risk and cost and replaced immediately. In case these are not removed, these will be auctioned at the risk and responsibility of the suppliers without any further notice.

8. Liquidated Damages

Supply of material will have to be completed within four weeks or the period mentioned in the purchase order. The liquidated damage charges @ 0.5% per week shall be imposed if supply is made after the expiry of the delivery period subject to a maximum of 10% of the total value of goods/contract value. Quantum of liquidated damages assessed and levied by the NIPER Ahmedabad shall be final and not challengeable by the supplier. Late delivery charges will be levied only on the late-delivered items.

9. Risk Purchase

If a successful Bidder fails to supply material within the stipulated delivery date or material supplied other than the specification specified in the tender, NIPER Ahmedabad reserves the right to procure the same or equivalent material from alternative sources at the supplier's risk, responsibility, and cost. Any extra cost incurred in the procurement of the material from an alternative source will be recovered from the Security Deposit / Bank Guarantee and Pending Bills and if the value of the materials under risk purchase exceeds, the amount of Security Deposit and/or Bank Guarantee and Pending Bills, the same may be recovered if necessary by due legal process.

10. At any time prior to the last date of submission of the bid, Director, NIPER Ahmedabad, for any reason or decision, can modify the terms and conditions of the tender document by a corrigendum displayed on the CPPP as well as the website of NIPER Ahmedabad http://www.niperahm.ac.in In order to provide reasonable time to take the amendment into account in preparing their bid,

Director, NIPER Ahmedabad may or may not, at its discretion, extend the date and time for submission of tenders.

- 11. The empanelment and rate contract is initially for the financial year 2023-24 and may be renewed/ extended for another two financial years on mutual consent, subject to satisfactory performance and on the same terms and conditions.
- 12. NIPER Ahmedabad reserves the right to keep the number of firms in the Rate contract for similar items during the period of the Rate Contract with one or two parties. Any parallel rate contract for similar items can be placed at any time during the period of the rate contract with one or more firms/manufacturers by NIPER Ahmedabad.
- 13. The empanelment can be terminated without any notice in case the performance of the party is found consistently unsatisfactory or due to a serious lapse on the part of the bidder. Where lapses are of serious nature in addition to termination of the contract NIPER Ahmedabad will forfeit its performance security.
- 14. The NIPER-A shall not be under any obligation to accept the lowest or any other offer received in response to this tender notice and shall be free to reject any or all offers.
- 15. The acceptance of the bid will rest with the Director, NIPER-A, who does not bind to accept the lowest quotation and reserves the right to herself/himself reject or accept, partially or all the quotations received, without assigning any reason. The Director, NIPER-A further reserves the right to withdraw the tender or part thereof or modify the requirements without assigning any reason and the right to relax any of the conditions in the best interest of the Institution.
- 16. Director, NIPER Ahmedabad shall be the final authority for the settlement of any dispute, and his/her interpretation of any clause/term/condition(s) of this document shall be final and binding, and the jurisdiction of the Court of Law shall be Ahmedabad / Gandhinagar.
