**Important Instruction / advisory:**

1. Call Letter to the Eligible / Provisionally applicants for Phase I of recruitment Process shall be issued in due course of time. Therefore, candidates are advised to check their emails (including spam folder) institute's website <https://niperahm.ac.in/> regularly.
2. The candidature of applicants marked as *Eligible* and *Provisionally Eligible* for Phase I (Pre-screening Test) is purely provisional. Admission to Phase II of the recruitment process (*Trade/Skill Test/Interview*) and subsequent stages shall be subject to:
  - i. Submission of the shortfall documents as mentioned in the "Remarks" column, **and**
  - ii. Successful verification of original documents at the time of the next stage.

**Failure to comply with these requirements may lead to disqualification from the recruitment process, even if the candidate qualifies in the Phase I of the recruitment process.**

3. **Document Verification:** The Institute will verify the antecedents and documents submitted by applicants at the time of Trade/ Skill Test / Interview or at any time, at the time of appointment or during the tenure of service. In case it is found that any applicant has submitted fake documents or the Applicant has undesirable clandestine antecedents/background and has suppressed the said information, his/her services shall be liable to be terminated.
4. Candidates who have applied for more than one post are requested to make their travel plans accordingly and be prepared to stay for two days at their own expense.
5. Candidates are advised to plan their travel well in advance to avoid any last-minute inconvenience.
6. Due consideration has been given to applicants who have applied for multiple positions. The examinations are scheduled in multiple shifts on the same day to enable candidates to appear for all the posts they have applied for.
7. The medium of the question paper will be English only.
8. The examination will consist of Multiple-Choice Questions (MCQs) and will be conducted using an OMR-based format.
9. **Important Advisory:** In case of any corrigendum/addendum pertaining to this recruitment process, the same shall be published on the Institute's website only. Accordingly, all applicants in their own interests are advised to regularly visit the Institute's website <https://niperahm.ac.in/>. They should also regularly check their email account for updates.
