The Department of Pharmaceuticals, Ministry of Chemicals and Fertilizers, Government of India has recognised NIPER-Ahmedabad as Centre of Excellence in Medical Devices through the gazette of India on 16th August 2023. This centre at NIPER-Ahmedabad will elucidate the objectives are aligned with the overarching goals of the Promotion of Research and Innovation in Pharma-MedTech (PRIP) scheme and the mandate of the Department of Pharmaceuticals. The Centre of Excellence in Medical Devices is established at the institute permanent campus in NIPER-Ahmedabad at Gandhinagar.

NIPER-Ahmedabad invites applications from dynamic, result-oriented and dedicated eligible candidates for the following positions at its **Centre of Excellence** on a purely contractual basis. These positions are temporarily created, based on requirement and liable to be increased/decreased/abolished as per the requirement of the project. The engagement shall initially be for one year and may be continued up to maximum duration of the project based on the performance assessment.

- Candidates who desire to apply for more than one post must submit separate forms for each application.
- Please ensure to upload the salary slips/ experience certificate from your employer towards experience claimed in the online application.
- There is no application fee for applying to any post.

GENERAL INSTRUCTIONS:

- Candidates of Indian nationality can only apply for these posts.
- All these positions are specifically for the Centre of Excellence (CoE) at NIPER-Ahmedabad
 and are strictly on a contractual and project basis, with no provisions for transitioning into
 permanent roles at the institute. The duration of these posts is project based and will
 conclude upon the project's completion. These roles are contingent on the continued
 funding and scope of the project, and it will not extend beyond the project's tenure. The
 number of vacancies indicated above may increase/decrease as per requirement and at the
 discretion of the Competent Authority.

- The selected candidate shall have no claim for regularization against the post.
- The positions are subject to periodic evaluation [every six months] of the performance of the incumbent and if, on such evaluation the performance is not found to be satisfactory, the contract will be terminated with one-month notice.
- No hard copies of applications should be sent to this office.
- No enquiry asking for advice as to eligibility will be entertained.
- The exact date and time for holding physical/virtual interviews of the shortlisted candidates will be intimated through e-mail or telephonically.
- The prescribed essential qualifications are the minimum and the mere possession of the same does
 not entitle candidates to be called for interview. The duly constituted Screening Committee will adopt
 its own criteria for short-listing the candidates. The candidate should therefore, mention in the
 application all the qualifications and experiences in the relevant area over and above the minimum
 prescribed qualification, supported with documents.
- For all the positions, the candidate must have the basic knowledge of Computer & MS office.
- The period of experience rendered by a candidate on part time basis, daily wages, visiting/ guest faculty will not be counted while calculating the valid experience for short listing the candidates for interview.
- In respect of equivalent clause in Essential Qualifications, if a candidate is claiming a particular qualification as equivalent qualification as per the requirement of advertisement, then the candidate is required to produce order/letter in this regard, indicating the Authority (with number and date) under which it has been so treated otherwise the Application is liable to be rejected.
- Any discrepancy found between the information given in application and as evident in original documents will make the candidate ineligible for appearing in interview.
- The appointment will be on full-time basis and he/she will not be permitted to take up any other assignment during the period of contract. The contract will be terminated by either party by giving one-month advance notice in writing.
- The consolidated emoluments are only indicative and shall be decided by the Selection Committee
 for the selected candidate based on his/her relevant experience and qualification. No other perks
 or allowances are admissible.
- The incumbent will be required to conform to the rules and regulations of NIPER-A in force from time to time and follow the discipline rules of the Centre failing which the contract may be withdrawn at any point of time.
- All educational, professional, and technical qualifications must be obtained from a recognized Board/University approved by AICTE/UGC. Only the experience acquired after the possession of the qualifying degree relevant to the position will be considered.
- Candidates must ensure that he / she fulfils all the eligibility criteria as stipulated in the
 advertisement. If it is found that he / she does not fulfil the stipulated criteria during the recruitment
 process, the candidature of the candidate will be cancelled. In case at any stage of recruitment
 process the documents/information provided by the candidate is found fake or misleading, his/her
 candidature is liable to be rejected.
- The incumbent will be entitled for leave as admissible to the contractual staff of the Centre.
